SATA GRAND PRIX PROGRAM RESPONSIBILITIES TO TOURNAMENT DIRECTORS

1. YOUR TOURNAMENT WILL BE LISTED ON THE SATA WEBSITE sactennis.org
2. PROVIDE EACH DIRECTOR UP-TO-DATE GRAND PRIX STANDINGS ONE MONTH PRIOR TO THEIR TOURNAMENT
3. PROVIDE AT LEAST ONE NEWSLETTER NOTICE OF TOURNAMENT DATES AND DEADLINES
4. PROVIDE A DISPLAYABLE CALENDAR TO ALL SATA MEMBER CLUBS LISTING THE ENTIRE SEASON

TOURNAMENT DIRECTOR RESPONSIBILITIES

1. ORGANIZE AND CONDUCT A POSITIVE TOURNAMENT EXPERIENCE FOR YOUR PARTICIPANTS
2. PROVIDE PROPER NOTIFICATION OF MATCH SCHEDULES FOR YOUR PARTICIPANTS
3. ESTABLISH FAIR AND PROPER SEEDING OF KNOWN ESTABLISHED PLAYERS
4. FOLLOW ALL USTA RULES AND REGULATIONS REGARDING TOURNAMENT ORGANIZATION AND PLAY
5. YOU ARE REQUIRED TO PROVIDE AN AWARD TO WINNERS AND FINALISTS IN ALL EVENTS
6. YOU ARE REQUIRED TO PROVIDE NEW TENNIS BALLS FOR EACH ROUND OF PLAY. IF YOU ARE CONDUCTING A ROUND ROBIN FORMAT WITH MODIFIED MATCHES, YOU MAY PROVIDE NEW USED BALLS FOR EACH ROUND
7. USE USTA 2010 POINT STANDINGS, RESULTS AND UP-TO-DATE GRAND PRIX POINT STANDINGS TO ESTABLISH YOUR SEEDING
8. YOU WILL BE REQUIRED TO SUBMIT YOUR TOURNAMENT RESULTS TO THE SATA GRAND PRIX COORDINATOR WITHIN SEVEN DAYS FOLLOWING THE LAST DAY OF YOUR EVENT. INCLUDE A PRINTED LIST OF NAMES AND E-MAIL ADDRESSES OF YOUR PARTICIPANTS
